

FIRE SAFETY CERTIFICATE

Certified that the **Tagore School**, 18, Mayapuri Marg, Mayapuri, New Delhi-110064, comprised of two blocks namely A-Block & B-Block. A-Block is having ground floor plus three upper floors was issued FSC by this department vide letter no. F.6/DFS/MS/School/2014/SZ/692 dated 06.06.2014 and B-Block having basement, ground floor plus three upper floor was issued FSC vide letter no. F.6/DFS/MS/School/2017/SZ/35 dated 09.01.17 owned/occupied by the Tagore School. The school was re-inspected by the officer concerned of this department on 12.02.2020 in the presence of Sh. Following fire safety directives must be adhered to:-

1. All the fire safety arrangements provided therein shall be maintained in good working condition at all times.
2. The means of escape arrangements shall be kept unlocked & unobstructed for speedy evacuation of occupants in case of an emergency.
3. Any loss of life or property due to non-functional fire safety measures shall be at the risk and responsibility of the management.
4. The trained staff should be available round the clock.
5. Any deviations w.r.t. construction shall be verified by the concerned building sanctioning agency.
6. Basement shall be used as per the building bye laws.
7. The certificate may not be treated in any case for the regularization of the unauthorized construction, if any.
8. The owner/occupier shall submit a declaration every year in the form 'K' provided in the first schedule of Delhi Fire Service Rules 2010, form is available on www.dfs.delhigovt.nic.in.
9. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director in the Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry.
